Brahmi Capsule

Brahmi Capsule (Perfect Brain Tonic)

Brahmi is a Sanskrit word that refers to the feminine essence of universal consciousness as well as the creative potential that emerges from pure awareness. "Brahmi" thought to promote subtle awareness and sattva (the pure essence of consciousness). Composition: Each 500 mg capsule contains: Bacosides 30% to 40% (400mg), Brahmi Micronized processed Powder (100mg).



Brahmi Capsule used here, is wet triturated with Brahmi juice/decoction to increase the potency of the powder. This process is known as "Bhavana" in Ayurveda. Bhavana is often used in Ayurvedic formulations to increase the potency and for the size reduction so that the efficacy of the product gets enhanced.

Chemical composition: Bacopa monniera contains alkaloid brahmine , nicotinine, and herpestine. Bacosides A $[3-(\alpha-Larabinopyranosyl)-O-\beta-D-glucopyranoside-10, 20-dihydroxy -16-keto- dammar -24-ene] was isolated from Bacopa monniera. Triterpenoid saponins, saponins A, B and C and pseudo jujubogenin glycoside were also isolated from Bacopa monniera.$

Bacopasides I , II , III, IV and V were also isolated from Bacopa monniera. Bacopa monniera also contained betulinic acid, D-mannitol , stigmastanol , β -sitosterol and stigmasterol .

Ayurvedic aspects: Ancient Ayurvedic sages, who were also great physicians, revealed Brahmi's role in promoting Medhya (intellect), Ayushya (longevity), Rasayana (rejuvenation), Prajna sakti vardhana (intellectual power), Hrdaya (Heart), Majjadhaty Rasayana (nervous system rejuvenation), Balya (strength, especially mind), Jivaniya (life energy), Nidrajanana (sleep), Dhana (wealth), Svara (voice), Varna (complexion) and Anuloma (redirecting the flow of vata downwards). Over the centuries, the role of Brahmi in the management of skin disorder, Pandu (anemia), Meha (diabetes), Asra Vikara (blood disorders), Kasa (cough), Sopha (edema), Jwara (fever), Vatahara (vata), Unmadahara (mental illness), Unmada (insanity), Alaksmi (inauspiciousness), Apasmara (epilepsy), Papa (evil deeds), Krtya (black magic), Ruk (pain) and Manasavikara (mental disorders) have been well described.
